The mission of Creating Opportunities is to support children and adults with developmental disabilities, their families and their communities in Oregon's Marion, Polk and Yamhill Counties in creating opportunities together.

Creating Opportunities is a 501(c)(3) tax-exempt non-profit organization and a 170(b)(1)(A)(vi) Public Charity.

At the end of 2019, Creating Opportunities had more than 1,800 Members and 1,365 likes on Facebook @2CreateOpportunities.

Employer Resource Connection: Oregonians with developmental disabilities eligible to receive assistance with daily living activities may hire Personal Support Workers (PSWs) for this support. The Employer Resource Connection is a program of the Oregon Home Care Commission that assists those eligible to hire PSWs through Developmental Disability Services and/or their proxy to become effective in their role of recruiting, training, and managing their employee(s). In 2019, Creating Opportunities:
-Provided 288 people with direct one on one customized support. Of those, 86 were new participants. Consultants helped these employers understand their rights and responsibilities; post job announcements; practice recruitment strategies; and create a PSW Handbook that outlines their preferences and expectations which will set them up for success as they train and manage their staff.
-Presented ERC program information to 25 groups of community partners as a free resource to those eligible to hire their own PSWs.
-Presented 12 Employer Resource Connection workshops to highlight various features of the program to potential participants.
-Attended 12 Oregon Home Care Commission's ERC Consultant meetings to stay informed on program and policy changes.
-Attended 10 Oregon Home Care Commission's PSW Training Committee meetings; Served as Committee Chair and shared valuable input about PSW-related training topics. (PROGRAM ACCOMPLISHMENTS CONTINUED ON SCHEDULE O)

Regional Family Network: We strengthen families through support, information, advocacy, and family events. In 2019, Creating Opportunities hosted a dozen family events to facilitate connections between families, including Family Paint Studio Party, Valentine's Party, Sensory Friendly Carousel, Mom's Day Out, Summer Swap, Miniature Golf, Weighted Blanket Party, Pumpkin Patch, Parents Night Under the Stars, and New Years Prep Party. These regional events were often attended by dozens of family members. Creating Opportunities hosted more than 20 training events, many in collaboration with community partners, including the following topics: Alternatives to Guardianship, Create a Colorful Life for Your Family, Diagnosis Discussions, Finding Hope in Moments of Crisis, Raising a Self-Advocate, Respecting Healthy Boundaries, Sensory Strategies, Strengthening Marriage While Nurturing Your Child with Special Needs. In partnership with several partner organizations, we hosted a Safe & Secure Symposium which featured several presentations relating to health and safety. We hosted a Creating Leaders training series to help selected parents become effective social justice advocates for themselves and others. Creating Opportunities held our 5th Annual Celebrating Achievements Awards Gala in March 2019 which featured honored children with disabilities for their individual strengths and personal successes. More than 180 people were in attendance. (PROGRAM ACCOMPLISHMENTS CONTINUED ON SCHEDULE O)

GO! Project: Creating Opportunities provided coordination for the Oregon Developmental Disabilities Coalition's Grassroots Oregon Project. Strengthened by a coalition of dedicated advocates, the GO Project works to identify policy issues concerning Oregonians with developmental disabilities, raise awareness about disability related issues, support individuals and families to understand the legislative process, help citizens become more comfortable in sharing their personal stories and perspectives with state leaders. While most of the project coordination is conducted through the Oregon Developmental Disabilities Coalition's website, email and social media profiles, Creating Opportunities also coordinates occasional GO Project legislative advocacy trainings at the State Capitol. We participate in DD Coalition Policy Committee Meetings and publish the GO Bulletin in close partnership with the Policy Director of the Oregon Council on Developmental Disabilities. In 2019, we published 22 GO Bulletin newsletters via email to a database of more than 2,750 members statewide. We maintain the newly designed Coalition website at www.orddcoalition.org and the Coalition's Facebook profile that has more than 2,250 followers. Note: We met directly with various state legislators to discuss the importance of funding for DD Services, and to request continued funding for regional family networks.

Part IIA 11 - GO Project coordination also involves limited administrative support to the Oregon Developmental Disabilities Coalition such as email monitoring, social media management, website updates and policy committee participation to develop and disseminate advocacy information.

Creating Opportunities was also contracted through the Oregon Council on Developmental Disabilities to coordinate the Alliance for Early Intervention (www.oregonael.org) to provide information, training and tools to families and educators of young children with disabilities to help them understand the legislative process and encourage them to connect with their state legislators to share personal stories about how public policy or budget decisions may impact them. This contract work also includes sending email newsletters to subscribers, publishing fact sheets on policy issues, hosting periodic advocacy training events, email monitoring, social media management, website updates and policy committee participation to develop and disseminate advocacy information. Alliance for Early Intervention represents approximately 2% of the work done by Creating Opportunities. Creating Opportunities does not endorse any political candidate.
