In most of the countries where our staff work and travel, it is often hard to use a credit card. Outside of major cities cash is the only medium of exchange. Rather than carry large amounts of the organization's cash, our Executive Director carries his own cash, and then submits receipts to Spring Rain International for reimbursement. This debt also includes the cost of airline tickets which the Executive Director purchases on his own credit card. Receipts are then submitted for reimbursement.
