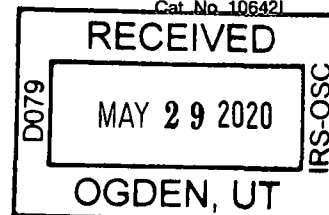

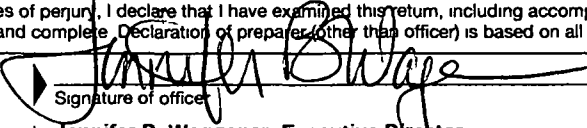

The organization's primary purpose is to provide free, volunteer services to senior citizens in Kanawha and Putnam counties (West Virginia)

to help meet basic needs, improve quality of life, mitigate isolation, and support their desire to age in place, safely and with confidence.

Part III, Line 28 : The organization's primary, core services include door-to-door transportation to medical appointments; transportation to or

personal assistance with grocery shopping/food access; and phone friend matches for weekly reassurance phone calls. In 2019, our

volunteers provided 785 rides to medical appointments, 284 trips to the grocery store, and nearly 700 reassurance calls in service to nearly

500 area senior citizens. We also purchased groceries outright, and offered emergency assistance with utility payments on a limited basis.

Staff also conducted 108 intake visits of new applicants during 2019, and traveled more than 11,000 service miles.

Part III, Line 29 : The services we provide to seniors in our community are 100% FREE because we manage a robust program of volunteer

recruitment, training, retention, and management. Cultivating and retaining a single volunteer is a task requiring many hours; the challenge to

maintain a volunteer corps capable of meeting the ever-growing demand for our core services is great. It involves engaging community

partners, raising awareness, hosting training events, and employing ongoing retention efforts. We also invest in powerful scheduling &

data tools that give our volunteers much flexibility, maximizes communication opportunities, and increases engagement.

In 2019, our volunteers contributed 4,118 hours of service to our community at a benefit value of \$91,790.

Part III, Line 30 : Our Honey Do Crews program provides minor home repair and maintenance projects to seniors in our two county service area, with a priority on projects that enhance their safety and general quality of life. We install grab bars and hand rails, replace/repair doors and windows, construct safety handrails, repair ramps, stairs, decks, and porches, and more...utilizing 100% volunteer power. In 2019, our Honey Do Crews volunteers completed 61 projects for 57 seniors at an average cost of \$65 per project. All of this great work was done by utilizing 102 volunteers, who contributed more than 340 hours.

Part III, Line 31 : Our Senior Christmas initiative brings together seven community agencies and volunteers to provide holiday joy for our older neighbors. In 2019, we were able to provide Christmas for nearly 100 seniors in Kanawha County, West Virginia, utilizing 57 volunteers who contributed 166 hours.
