Our goals are to bring creative people together, to serve as an incubator for imaginative solutions for everyday problems, to make opaque scientific and technical concepts accessible to everyone through education and to provide much needed services to our community, made possible by the skills and passion of our membership.

Classes: Teaching classes for the community in diverse areas of technology and art. Over 200 offered courses in 2D/3D design, fabrication, welding, 3D printing, laser cutting, arts and crafts including jewelry making, leather working, sewing, woodworking and more. In 2019 our education after-school program developed four new programs: Maker Installs, Teach TXRX, Middle School Makers Summer Camp and Tour TXRX. Maker Installs program installed high-tech prototyping and fabrication equipment or "maker spaces" in 7 schools where the objective is to change young students understanding of modern design and production and allow teachers to implement hands-on, minds-on lesson plans into their curriculum that stimulates student engagement. 72 teachers participated in Teach TXRX, a professional development program for teachers where educational consultants support a Maker Install school and other teachers who want to integrate production equipment into lesson plans or after school clubs and programs. Middle School Makers Summer Camp taught 45 students over the course of three weeks. Tour TXRX is a enriched, fully funded field trip program which reaches schools who do not have equipment on campus or transportation to visit TXRX. Months before the field trip TXRX educational consultants visit the schools to explore themes, projects or academic lessons that can be brought to TXRX for and then return to the school for project presentation.
