We have estimated that \$174,754 of our bad debt expense should have been classified as charity care, if the appropriate paperwork was received. These are the dollars that should be classified as community benefit.

We provide a number of exercise programs for the elderly in the community. We host an annual health fair to reach out to those who do not regularly schedule a clinic visit or annual lab tests.
