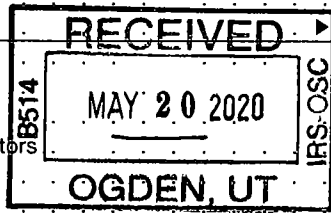



Open Blue continues to engage in activities that build our endowment as well as fulfill our exempt purpose. We continue to

contribute to conservation efforts, spiritual development and other efforts to acknowledge and transform suffering

in society. We also contribute to spiritual, environmental, and self-care education.

Open Blue has offered indoor and outdoor meditation opportunities and continues to work with The 3 Doors to investigate how we might

develop local programs to benefit caregivers and inmates. While we haven't launched any local program to date we've helped develop

and refine these programs through The 3 Doors and Ligmincha International Organizations

This year we gave \$1800 to The 3 Doors Organization (Three Doors; EIN# 27-3293201). This funding was offered to support program

development by this organization. Open Blue has pledged this amount for three years, this being year 2 of 3

This year we launched an online program exploring the individual and collective suffering associated with global climate change and the

sixth extinction. This is an international gathering of long-term practitioners. Our aim is to voice our experience and to bring the difficulties

of a failing planet into our practice, facing the challenges we face and renewing our connection to nature. Along the way we've developed

new relationships with ourselves and the planet that supports us. Much of the training and inspiration to create this course is reflected in the

expenses reported in the Schedule O pages that follow.
