In Haiti, AMURTEL works with over 1800 women living in severe poverty, offering Self Help Groups, Micro Credit loans, health and literacy programs, and programs for over 1000 of teen age girls. We provide support for two children's homes with a total number of 40 children, ranging in age from 2 months to 14 years. AMURTEL also supports three schools offering grades pre-k through 9th grade. Combined enrollment is 1200 children, all from families living in extreme poverty. Students are given a hot meal each day.

In India, AMURTEL supports schools and homes for girls in West Bengal, an area considered one of the poorest in India. We are supporting the construction of a girl's college in the area, as education is one of the most effective ways to help girls and children in general break the cycle of poverty. We continue to support the construction of a hospital in Kolkata and a home for elderly women who have no family to take care of them.

In Greece, AMURTEL supports the Mother's and Babies project, a program designed to help migrant families with children up to age 2 years and younger. Pregnant women and new mothers receive support in all maternity areas, including ultrasounds during pregnancy, translators during hospital births, lactation support, and parenting classes that address nutrition, and overall baby health.
