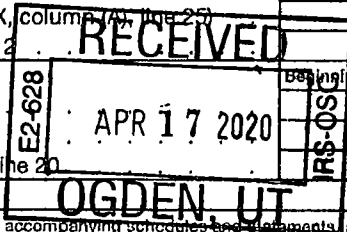

To achieve our mission ProUnitas operates two programs: PurpleSENSE and Resource Map.

PurpleSENSE: This technology-driven framework empowers schools to more effectively address whole-child health within a school. ProUnitas trains school counselors and/or social workers, service providers and school staff to use PurpleSENSE which utilizes risk factors like attendance, behavior infractions, and failing grades to identify students needing support and/or provide enrichment. In addition to that PurpleSENSE systemizes a referral system for teachers and parents to request assistance. Following that schools support staff can work with the student and their families to more effectively connect students to the various in-school interventions, non-profit services and other out-of-school services. PurpleSENSE also allows parents to support staff to see if students accessed the service and if the services are helping with their attendance.

Resource Map: Along the vein of ensuring ALL students receive the right resources at the right time, ProUnitas is focused on family empowerment and student self-advocacy. This Resource Map is a dynamic, free online resource map broken down by campuses across school districts. Parents, students and school leaders are able to see what resources their individual school has.
