Provide opportunities & support for short term mission trips. Support ongoing education support of orphans, missionary families, and families at mission hospitals.

Financial support provided to Tumaini Childrens Home, a non-profit corporation in Eldoret, Kenya. Funds used to provide for the daily needs of 44 orphaned children, including food, clothing, shelter, education, and medical care. A new home was completed to house a second mission family to support the work at Tumaini Childrens Home. The childrens home is managed by missionaries Horace & Phyllis Leister, with support from missionaries Josh & Rachel Leister. The childrens home employs a staff of 12 Kenyans including 3 certified schoo teachers and a certified social worker. These employees care for the children 24 hours per day, 7 days per week, assist with farming (raising crops consumed at the childrens home) home and grounds upkeep, and night time security. The only overhead type expenses associated with the childrens home were wire transfer fees for sending funds from a US bank to a receiving entity in Kenya.

Tumaini Childrens Home will continue to be supported by Family Keys International. It is hoped funds can be raised to construct a larger school building to accomodate the increased number of children now living there. Additional farming equipment and a larger vehicle for transporting more children at one time are also hoped for.

Financial support provided to missionaries Horace & Phyllis Leister for subsistence and personal needs. Horace & Phyllis manage Tumaini Childrens Home. Funds provided to Tumaini Childrens Home can not be used for the personal needs of Horace & Phyllis Leister per rules of the Kenyan government and guidelines of Tumaini Childrens Home non-profit organization. Funds provided by Family Keys International to Horace & Phyllis Leister were used for food, clothing, medical expenses, and travel to visit supporters in the United States and Great Britain.
Family Keys will continue to support missionaries Horace & Phyllis Leister in coming years.

Financial support provided to missionaries Josh & Rachel Leister for subsistence and personal needs. Josh & Rachel assist at Tumaini Childrens Home. Funds provided to Tumaini Childrens Home can not be used for the personal needs of Josh & Rachel or their children per rules of the Kenyan government and guidelines of Tumaini Childrens Home non-profit organization. Support from Family Keys International to Josh & Rachel Leister were used for food, clothing, medical expenses, travel the mission hospital where Josh volunteers as a surgeon's assistance, and travel to visit supporters in the United States.
Josh also provides volunteer medical assistance at the childrens home and in Eldoret, Kenya.
Family Keys will continue to support missionaries Josh & Rachel Leister in coming years.
