The aims of the project are to support the return of the most vulnerable and undertaking a multidisciplinary, supervised program which includes livelihood and economic independence, supporting access to services including social cohesion and psychological support, diaspora engagement, and administrative support. The activities includes opening small businesses for returnees in Sinjar, supporting teachers and students, supporting schools with school supplies, supporting youth groups for community and youth activism, and providing psychosocial support. Yazda supported, educated, and empowered survivors in their ability to build legal cases and utilize available legal systems, assisting them with obtaining proper documentation and explaining their legal rights under various jurisdictions in Iraq. The program provided 280 beneficiaries with MHPSS. 120 beneficiaries participated in a trip to Lalish for social integration. 34 small businesses/income-generating activities were opened for survivors. 350 beneficiaries were supported with legal assistance.
