The Organization aims that by telling the stories of the automobiles, it tells the story of our culture, country, families and ourselves. During calendar year 2019, the organization curated three (3) exhibits and hosted 20,000 visitors, including school and senior groups.

The Organization, through its wholly owned subsidiary, Audrain Concours Foundation, LLC, produced and hosted the inaugural "Audrain's Newport Concours and Motor Week," a four-day car centric experience in Newport Rhode Island. From October 3, 2019 to October 6, 2019, the organization conducted 5 educational seminars on automobile related topics and a Tour d'Elegance, fundraising Gala and Concours d'Elegance each of which celebrated and promoted the public's interest in the preservation and presentation of automotive history.
