NWDP rescued 148 dogs in 2019 and adopted 133, compared to 139 and 130 in 2018. We took on some dogs with behavioral challenges that required more investment in training. We are happy to say that with the help of our wonderful trainer, we were able to get those dogs to a much healthier place and they have all now found great forever homes. We also took on several more younger major medical dogs than in previous years and were able to rehabilitate them and adopt them out to loving homes.

In 2019, we continued our senior program and rescued 23 senior dogs, 4 more than we took in in 2018. Many of these seniors had extensive medical needs and we were able to provide several of them with major surgeries and on-going quality care. We have stayed involved in our community with our "Seniors for Seniors" program, taking our senior dogs to a local memory care center.

We continue to offer financial assistance to low-income families needing support with medical bills ranging from routine vet care, spays/neuters, and other surgeries. We were able to contribute to spay and neuter programs both locally and in CA, and have a goal of fully sponsoring our own spay/neuter clinics four times each year beginning in 2020. Our team also donated our time and supplies (food, flea treatment, jackets, toys, etc.) to a couple of local events offering assistance to the unhoused in our community.
