Provide groceries to need families in an atmosphere of quality. We aim to be transformational rather than transactional, lifting spirits & create resilience in addition to filling stomachs. We provided 190,000 pounds to 9,462 individuals during 3,123 family visits. Food incl. fresh produce and meals which has a positive health effect on our guests. We distributed 256 family Thanksgiving dinner including w/ whole turkey, fresh potatoes, and frozen pies. We also distributed clothing, household goods, backpacks, grocery carts, Easter baskets, coats, hats, mittens, and Christmas gifts to families utilizing more than 7,600 volunteer hours. We connected our guests more than 1,000 times to other agencies to meet other critical needs. Provided limited emergency grants to meet utility, transportation, or housing needs of individual families. Every dollar of cash expenditures were multiplied to provide \$4 of groceries for need families.
