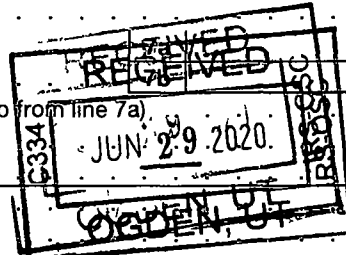

Cancerland (#Cancerland is the name registered with NY State) was created by Ms. Champagne Joy as a charity to aid women with breast cancer. She developed metastatic cancer and died of complications in 2017. Before she died she had conceived of a fashion show during NY Fashion week that would feature amateur models who had breast cancer, many with masectomies. The 2018 show which was held in her memory was the high point of Cancerland's charitable income however it demonstrated that such an event was really beyond the ability of the small group of volunteers. The board had elected Michael Hall (Ms. Joy's husband) successor President however he had no experience running a not-for-profit. For 2019 Cancerland turned over the fashion show to MetaVivor (the national charitable organization funding research into metastatic breast cancer). Cancerland's volunteers continued to assist with the show but Cancerland took no income from it. The board of Cancerland decided that there was no need to continue as a seperate charity and so a grant was authorized of \$25,000 to MetaVivor and \$2500 to the Norma Pfreim Breast Cancer Center. Cancerland never paid salaries, never paid rent and had no financial obligations whatsoever so it was ready to dissolve. The attached is its final return.

\$884 was expended purchasing food, paying for parking and other expenses for the volunteers who assisted in the 2019 Fashion Show
