WITHOUT THE BENEFITS OF THESE VOLUNTEERS, THE PERCENTAGE OF PROGRAM COSTS COMPARED TO THE OVERALL COSTS WOULD BE MUCH HIGHER. THE ORGANIZATION IS ABLE TO USE THE CASH SAVED TO PAY FOR ADMINISTRATIVE COSTS, OTHER PROGRAM COSTS, AND EVEN SOME FUNDRAISING COSTS. HOWEVER, IT IS IMPORTANT TO NOTE, THAT THE TRUE AMOUNT THE ORGANIZATION ALLOCATES TO ITS PROGRAMS IS MUCH HIGHER THAN IS REPRESENTED ON THE STATEMENT OF FUNCTIONAL EXPENSES.
