


Compassionate Atlanta hosted six conversations (events) on building a welcoming community on equal access, healthy eating - how to combat the food deserts that exist, inclusion in the media, compassion for the environment, refugees and developmental disabilities, and the intersection of sexual orientation, gender and disability. CATL had upwards of "384" people join us for the community dialogues, international day of peace, DeKalb Remembrance Project and events at Emory's Rollins School of Public Health, CSU, CPB TV and the Alliance Theater.

Compassionate Atlanta offered Compassionate Integrity Training Classes in 2019 in a number of locations with attendees ranging from early childhood teachers and elementary school teachers to Chaplains at Grady Hospital, Gwinnett Medical Center, and Northside Hospital, to inmates at Phillips State Prison. These classes continue to be a favorite offering and at Phillips State Prison a weekly meeting as a follow-up group has developed.

Compassionate Atlanta became the Fiscal Agent for "A Home For Everyone In DeKalb". We collaborated with places of worship to provide overnight space/shelter for the homeless in DeKalb County whenever the temperature drops near or below freezing. We hosted approximately "70" different individuals with an average of "20" per night.
