The CAL visits every elementary school and meets with all students about the humane treatment of animals, the importance of spaying and neutering.

WWVARA supports the humane treatment of animals of the Huntington Cabell Wayne Animal Control Shelter by paying the salary of the cat technician, purchasing cat and dog food, litter, vaccines, flea medicine, dewormer, veterinary care for shelter pets (including animals held for court cases). WWVARA has also paid for shelter improvements such as the playyard fencing, storage buildings and windows.

The shelter also provides for the position of Executive Director at the Huntington Cabell Wayne Animal Control Shelter.
