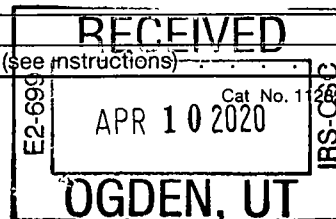

**Supplemental Information for Parts I, III, and IV**

The organization's primary purpose remains as in previous years, to help veterans in need, including underwriting the expense of medical transport for wheel chair bound veterans to their required medical appointments, to assist deserving veterans with support such as finances, food, shelter, filing of VA claims, utilities, rent, furniture, moving help, etc. This year the organization expanded its outreach into the area of finding housing for homeless veterans in the Lynchburg, Virginia area and the surrounding contiguous counties.

Part III, Line 4a: The organization was able to obtain residential rental property located at 1309 Garfield Avenue, City of Lynchburg, and convert it into a home for three veterans who were previously homeless. This home has special historical significance as it is the birth place of World War II Medal of Honor Recipient Desmond T. Doss, made famous in the Hollywood movie "Hacksaw Ridge." This home has been dedicated as The Desmond T. Doss Veterans Home, and will house previously homeless veterans into perpetuity. This was the organization's biggest program in terms of expenses. The organization is undertaking efforts to purchase the property and should have that accomplished during tax year 2020.

Part III, Line 4b: Motorcycle Missions is a program the organization is undertaking to attempt to reach veterans and first responders that might be suffering from PTSD. The program brings people together to build relationships and community, usually around building a motorcycle. This was the organization's second most costly program in tax year 2019.

Part III, Line 4c: The organization assisted the Lynchburg, Virginia Chapter of the Military Order of the Purple Heart in establishing a Memorial Brick dedication honoring veterans and first responders in the Lynchburg Area, located at the Monument Terrace Memorial.

Part III, Line 4d: The organization has further expanded its efforts in the area of veteran PTSD by partnering with a certified companion dog trainer, who adopts "rescue" dogs, trains them, and then places them with veterans who need a faithful companion.

Part IX A, Lines 1 and 2: The organization has made considerable financial grants in order to directly help veterans, and their families, in need. The following is a list of the major grants paid: 1. Individual cash donations - \$12,968.24; 2. wheel chair transport - \$6645.00; 3. other veteran group assistance - \$8339.95; 4. New Freedom Farm horse therapy for vets - \$5000.00; 5. Man at Arms Ministry - \$5350.00; 6. D - Day Memorial in Bedford Virginia - \$1000.00.
