CPI uses its research, medical and pharmaceutical expertise to invest in first-rate science that will discover new strategies for preventing cancer. Our strategy is to support research on prevention of inherited cancers as a path

In 2019, the HeritX name was changed to Cancer Prevention Initiative (CPI). The new name better reflects our mission, purpose and strategy. CPI's work continues to support ongoing projects initiated in 2017 and 2018. One of these projects involves an international collaborative cancer prevention vaccine project at the Netherlands Cancer Institute, Dana-Farber Cancer Institute, Johns Hopkins University, and ISA Pharmaceuticals. We released a global request in 2018 for new BRCA cancer prevention research proposals for funding in 2019. Projects funded through this competition included a project at Memorial Sloan Kettering Cancer Center to develop approaches to detect loss of the functional copy of BRCA1 and BRCA2 in "normal" human breast and ovary cells, and a proposal at Cleveland Clinic to design a preventative vaccine for breast cancer in women with inherited BRCA1 mutations.

Education and community engagement programs: In 2019, HeritX changed its name to Cancer Prevention Initiative (CPI) and broadened its focus. Specifically, we have expanded the mission to include discovery of new preventive vaccines and medicines for all inherited cancers. While BRCA related cancer prevention and research continues to be at the center of the investigative process, the expanded focus includes inherited cancers such as those in patients with Lynch Syndrome, caused by inherited mutation in MMR genes. Lynch Syndrome affects approximately one in every 300 individuals. One of the goals is to enhance the scientific reach of the organization and raise awareness on cancer prevention to a broader audience of patients, advocates and donors. Thus, regular updates on scientific and medical research advances, recent clinical trials, and interviews with experts in cancer prevention are published on web-based platforms. CPI designed a new website that includes highlights of new progress in the cancer prevention field that is relevant to a broad audience. This information is also freely available through a mailing list subscription. As we move closer to our goal of eradicating all cancers through preventative medicines, we believe that educating the public and raising awareness about inherited cancer syndromes will inspire more individuals to take proactive, life-saving preventive measures.
