| <p><b>28</b></p> <p>In FY 2019 the Organization completed approximately 5 Tribal Environmental Summits on the Nez Perce Reservation at the Clearwater River Casino. These had movies, presenters and speakers from across the Pacific Northwest as we targeted the Indigenous people of the Northwest. Total attendees ranged from 30 to 85 at these events with a wide range of topics, including dam breaching and salmon recovery, Oil and Coal Train issues, water quality, forest protection and pushing for moving away from fossil fuels. We also have participated in and worked on the 5th Free the Snake Flotilla where approximately 350 people attended with 150 watercraft. We have begun showing our Healing Journey dugout canoe video, in Washington, Oregon and Idaho. The Organization continues to work with 35 4th and 5th graders coming to work on arts and crafts, beadwork, and other traditional activities. Learning about the environment and such issues as solar power, plastics, clean energy and other topics every Wednesday. The Organization continues the canoe paddle making class along with the students and adults each week. Additional accomplishments include the expansion of activities the Organization offers to include arts and crafts classes taught by Tribal elders.
