28 Service Area - Public Health PerformanceRed Star International partnered with a public university to deliver a tribal public health performance training to tribes in Oklahoma, Kansas and Texas. More than 50 representatives attended the training. Red Star also co-delivered 2 national webinars using the same curriculum to make the content available to tribes across the US. Representatives from 16 tribes, 3 states and 1 federal agency attended the webinars. Red Star also partnered with a tribal organization that serves 40 tribes to conduct a needs and assets assessment to improve public health performance. A key outcome of the assessment was a technical assistance plan aimed at improving public health capacity among the 43 tribes. Through funding from the Centers for Disease Control and Prevention, Red Star provided training and conducted a community health assessment and provided a summary of critical public health data that will be used by the tribe in 2020 for community health improvement planning. Service Area - Indigenous Knowledge Sharing and Best PracticesThrough a grant from the Robert Wood Johnson Foundation, Red Star facilitated the first part of international Indigenous knowledge exchange to explore capacity development in the area of governance, water resources management, shared services and best practices. Activities planned for 2021 (pending the pandemic) include: 1) hosting a reciprocal visit as part of the exchange between Indigenous communities in the US and New Zealand; 2) convening a state-wide forum on tribal governance and water resource management, and their impact on health; and 3) developing resource materials and an educational video for national dissemination.
