THE ZIP CODE WILMINGTON PROGRAM IS COMPRISED OF A SOFTWARE DEVELOPMENT TRAINING SCHOOL AND A JOB PLACEMENT PROGRAM. STUDENTS SPEND 12 WEEKS LEARNING THE FOUNDATION NEEDED TO SUCCEED IN SOFTWARE DEVELOPMENT, AND SELECTED GRADUATES MOVE DIRECTLY INTO FULL-TIME JOBS AND PAID 26-WEEK APPRENTICESHIPS AT AREA CORPORATIONS UPON GRADUATION. AS OF DECEMBER 2019, ZIP CODE GRADUATED 339 STUDENTS, WITH 85% OF THEM PLACED IN PAID ROLES WITHIN 6 MONTHS OF GRADUATING, WITH ANNUAL EARNINGS AVERAGING OVER \$65,000 PER YEAR.
