The first project was for the University of Houston which was approved to receive \$188,370 for the Solar Power Generation & Sustainability Demonstration Initiative which will reduce energy usage by 16.7 kW and \$64,454 for the school's Enhanced Photosynthesis Teaching Initiative. The second project was for \$300,000 to Discovery Green Park for new innovative LED lighting in the Northwest corner of the park. The third project was for \$151,141 to Global Links for a 63.2 kW solar array which will offset 82% of their electricity needs.
