<p><b>28</b></p> <p>Pick TN Conference's mission is to support local producers and enhance their access to suppliers, education and training, provide networking opportunities, and increase the competitiveness of specialty crops throughout the state. The conference is vital to the survival of the member organizations: TN Fruit &amp; Vegetable Association, TN Association of Farmers Markets, TN Christmas Tree Growers Association, TN Farm Wine Growers Association, TN Agritourism Association, TN Beekeepers Association, TN Organic Growers Association, and TN Flower Growers Association. An Executive Director was hired to be a central contact and easily allow each organization to work together to enable success for all involved. The Executive Director began working in March 2016 to be the central contact for the associations and to coordinate planning the conferences each year including securing the hotels, and creating the conference programs, workshops, and trade show exhibitions. Meetings were held each month with member associations to begin planning the yearly conferences. The director met with the hotel to secure the venue for the 2018 conference and also secured a venue for the 2019 conference. The director is the central contact for the associations and has worked on the conference program, including speakers, classes, and trade show exhibitors. The conferences are only one in TN that serves as a central location and as a continuing education venue for the 8 state wide member associations. The goal of the conference is to provide educational programming and networking in a collaborative environment, which fosters growth to sustain agriculture. The conferences have grown steadily every year with 300 attendees in the first year in 2016 to 635 attendees in 2019. The Pick TN conference was held in February 2019 and was very successful with over 600 attendees.
