
Please be aware that we exercised ordinary business care and prudence, but due to circumstances or events beyond our control due COVID-19 we were unable to completely timely file the return as we believe did it. We are returning the Form 990-EZ signed with the complete Schedule B and Schedule of Contributors.

As you may know we didn't know until receive your letter about the issue However, we are doing all in our end to comply with the law and will detail any contributor as required to prevent this on the future. This is the first time we have this kind of issue since we received those grants as you will see.

The above explanation constitutes *reasonable cause* under the law. We continued to attempt to meet the requirements, even though late. The length of time between the event cited as a reason for the noncompliance and subsequent compliance was not significant under current circumstances. We did not fail to timely correct noncompliant behavior. In preceding tax years the same penalty has not been assessed. Our overall compliance history is excellent. Please we will appreciate if entitled to relief from the penalty.

Please follow appropriate procedures to **stop automatic assertion of a failure to file penalty** and advise me as contemplated by IRS Policies and IRM.
