Founded in 2014, The Azraq Center is an academic enhancement program providing remedial education and enrichment opportunities for Syrian refugees and vulnerable Jordanians in South Azraq, Jordan. The Azraq Center hosts 245 started at level Pre-K and up. We offer daily instruction in Arabic, English, Math, Science, IT, Art, Music, and more for some of the most vulnerable children in Azraq. Our program aims to benefit the wider community through regular outreach, awareness sessions, humanitarian aid distributions, and other activities.

**4b** (Code \_\_\_\_\_) (Expenses \$ 7,416 including grants of \$ 0) (Revenue \$ 0)

The organization provides critical humanitarian aid to families in need. We distribute regular food and hygiene supplies. Food distributions include staple items like rice, oil, beans, and other non-perishables. Hygiene items include soap, shampoo, diapers, and feminine hygiene products. We also respond to emergency situations like extreme weather or medical needs as they arise.

**4c** (Code \_\_\_\_\_) (Expenses \$ 59,361 including grants of \$ 58,761) (Revenue \$ 0)

The Sal School was a one-year remedial education program for Syrian and Jordanian students in East Irbid, Jordan. The program was implemented in partnership with the Middle East Children's Institute (MECI). Students were provided with weekly instruction in Arabic, English, Math, Art, Music, and PE. The program included multiple field days, life skills trainings, and other social cohesion events. The program concluded in July 2019.
