28 Crisis Intervention - Chance Shelter offered our resources through alliances with Banner Del Webb and Banner Boswell social workers to foster pets while their owners were in crisis situations. We also assisted with some referrals from funeral homes and care facilities for pets needing to be adopted due to the owner's passing with no next of kin available to care for the pets. We continue to assist Surprise Animal Care and Control with pets that are available to be adopted. We operated strictly with our fosters and the help of volunteers, as we do not have a facility yet. We continue to expand our foster and volunteer lists to accommodate more pets. In 2019, we cared for 48 animals in crisis situations, including medical emergencies where the pets needed either permanent or temporary placement. We also provided some financial assistance for pet owners who could not afford the veterinary bill for their ill pet. Chance Shelter also provided rehoming assistance for 10 pets by way of a courtesy posting on our social media page and offering guidance in the steps necessary to rehome a pet. These events included: open houses at local fire stations, an annual city safety event, pet care/awareness classes for children and adults, presentations at local recreation and dog clubs, sporting events, fundraisers, and health and safety awareness events. We continue to offer pet CPR and first aid classes to both the public and our volunteers. We are expanding our presentations through invitations from local businesses and outreach groups which has helped to increase our number of fosters and volunteers.
