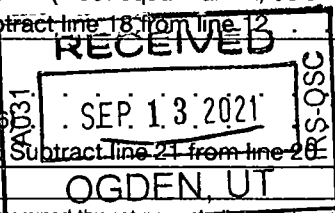

Pt I Line 3 Col (F): The Mount Ararat Discovery Foundation (MADF) has been established to seek out, document, and scientifically test, study and preserve artifacts found within or connected with the discovery of an ancient wooden structure on Mount Ararat that natives of the region have believed to be the remains of the Noah's Ark. Turkish native, Ahmet Ertugnul (Parasut) made this discovery by using information provided by his relatives who had lived on the mountains until shortly after WWI, but who now live in the neighboring countries, owing to the civil war in the areas. Until recently, political and military conflicts in this area prevented the families from sharing the secrets of the mountain which they carried with them into exile. The archaeological investigation of this study is being connected by Dr. Oktay Belli. Dr. Belli conducts a biannual Symposium of Mount Ararat and Noah's Ark. Parasut's long search for the discovery was funded by Hong Kong based Noah's Ark Ministries International. Clara Wei, a science writer for HK public television has long served as Parasut's spokesperson and business partner. Parasut and Clara's Epictudio LTD serves as the conduit for MADF to process grant money for the project.
