As part of our historic preservation program, we purchased 1247-1253 Whitney Avenue, Hamden, CT, 06517, a National Historic Landmark, which includes the Whitneyville United Church of Christ built in 1834 and its Church House built in 1924, and continued its legacy as a house of worship while continuing to adapt its use to a broader Community Resources Center and the facility in which we run our other programs.

Form 990, Part III, Line 4b:

Our assembly space program continued to be our most requested service, hosting more than 500 single and recurring events through the year, with an estimated attendance of 45 people to each event, we hosted more than 22,000 people over the course of the year. Events that took place at the WCC included: weekly Red Cross Mobile Blood Drives, Hamden Town Hall Meetings, Community Foundation for Greater New Haven Nonprofit Training Sessions, 8 Sororities and Fraternities and their Service Events and Annual Meetings, twelve churches and their worship and special event services, Planned Parenthood staff meetings, local area nonprofits holding fundraisers and trainings, senior citizen's gatherings, Christening Ceremonies, Quinceaneras, Weddings, Funerals, New Haven Legal Aid Organizing Meetings, Baptisms, and more. Having grown to average of five events per week, we were overflowing with the needs of the community for common space to meet in large gatherings to accomplish community needs.

Our Coworking Program provides a dynamic shared and private working environment that brings together startups, seasoned professionals, remote researches, freelancers, and solopreneurs, in a public space where they interact more regularly with each other and their community with lower overhead to insure viability of their small businesses, and to give new entrepreneurs a chance to make it in and a reason to stay in our local economy. This year, with new spaces opening up after successful ventures were launched, we welcomed more nonprofit partners into our campus facilities to pursue their missions and purposes. CTCore Organize-Now!, Public Allies CT, and NHDocs: The New Haven Documentary Film Festival all started using our coworking private offices and availing themselves of the support that comes with coworking in the vital atmosphere of the WCC with all of its additional technical, spacial, and arts amenities. CEIO and Encouraging Word Church stayed with us as coworkers, and grew in their development as organizations. And we served 10 individual coworkers throughout the year.

Our Arts and Culture Program provides studio space for artists, venues for performances and showcases and cultural events, space for classes and rehearsals, and tools for artistic productions, produced both in partnership with artists and offering our services as tools for artists to produce their own events. In 2019 we had 3 weekly recurring dance classes and hosted over 25 community dances. We had local and national artists choose our venue for their performances, hosting Damian McGinty, the CT Irish Theater Troupe, WCA Summer Music Jams, Documentary & Fictional Movie screenings from local movie makers, recitals from local music teachers, a book signing from local author, and the fifth annual Compassionfest with a 1000 attendees, as well as being a common space for local musicians to produce their own live concerts, and local visual artists to have pop-up galleries.

Our Materials and Information Library program allows us to offer a curated repository of items and information for managed public use, both onsite and offsite. It includes books, tables, chairs, multi-media equipment, office supplies, kitchen tools, lawn care tools, and more. It also includes our databases of information about the historic property, Whitneyville, and Greater New Haven, allowing us to slowly build a representation of our community that can let us help people find services and resources that they need that we don't provide. As we get repeated requests for objects to be available for use while at the WCC, we acquire them and add them to our library of objects. This year we purchased a number of chairs, linens, and multi-media devices, as well as receiving a number of donations of a wide variety of other items.
