Three watershed restoration and protection programs, two above the federal water supply reservoirs of Perry Lake and Tuttle Creek Lake, that provided cost share assistance to private landowners to address surface water impairments that impact the water quality of the watersheds and federal reservoirs. Pollutants reduced included sediments, nutrients, bacteria and livestock waste which affect public drinking water supplies. A total of \$118,750 in cost share was paid to landowners to install conservation practices to reduce pollutants from reaching the two federal reservoirs and the Kansas River and the Missouri River. Several educational workshops were held to inform landowners of the need for watershed protection and the impacts on water quality.

4b (Code:) (Expenses \$ 300,800 including grants of \$ 145,673) (Revenue \$ 88,340)
Regional economic development and small business development programs provided business training, workshops, business planning and financial assistance to entrepreneurs wanting to start a small business and business owners wanting to expand their growing businesses. Over 150 people were assisted and 30 jobs created or retained with these businesses. The Glacial Hills Food Center is a shared-use food processing facility provided space, equipment and services to four food businesses. The Glacial Hills Business Resource Center provided support, assistance and business planning to 80 entrepreneurs and meeting and office space for 15 businesses. The programs are a public-private partnership with Washburn University Small Business Development Center, local economic development commissions, chambers of commerce, banks and local officials. The Shawnee Co. e-Community is a program that cooperates with Network Kansas to provide loans and workshops to entrepreneurs and small businesses. Two businesses received loans to start their businesses which created 8 new jobs.
