 In addition to regular programs for youth, DeSoto Youth Ministries spent 2019 focused on relief efforts for individuals and families in need. Relief efforts included tornado disaster relief distributed to victims; a formal dinner under a bridge for hard core homeless and monthly serving the homeless. A new weekly youth program called RISE was initiated in 2019. Total attendance for programs, missions and special events totaled 1404.

4b (Code:) (Expenses \$ 150,762 including grants of \$ 0) (Revenue \$ 148,932)
 Cause Coffee estimated over 25,000 customers were served in 2019 and give-backs to the community included pastries monthly to homeless, coffee, food and cash to tornado disaster victims, blankets for infants, help for local needy families, a major project for Kansas School for the Blind, plus donations to help fight human trafficking, a coffee project in Honduras and an orphanage in Haiti.

4c (Code:) (Expenses \$ 63,843 including grants of \$ 0) (Revenue \$ 67,921)
 Staff traveled over 4,000 miles in 2019 following 2 youth rodeo associations to 18 different communities in Eastern Kansas where 33 rodeos were held. Youth and families were served at each rodeo, helping inside and outside the arena. 17 church services were provided for families on Sunday mornings before the rodeos with a combined church attendance of 2,500.
