Payments to providers and minor administrative costs to pay the partial cost of abortion care for Wisconsin residents & ensure safe legal equitable access to abortion. Women's Medical Fund (WMF) supported 930 people in 2019 with an average of \$413 each paid directly to medical providers after the completion of the procedure. All funds expended went to directly help Wisconsin residents cover the cost of abortion, with less than 1% of donated non-restricted funds spent on administrative costs. WMF has been a volunteer organization for 48 years.
