IN ADDITION: AUTISM SOCIETY PUBLIC POLICY TEAM HAD 100+ MEETINGS WITH LEGISLATORS ABOUT POLICY RELATED TO THE AUTISM COMMUNITY. 8,000 LETTERS WERE SENT TO MEMBERS OF CONGRESS IN 2019 TO ADVOCATE FOR RELEVANT LEGISLATION, WHICH MORE THAN DOUBLES THE AMOUNT OF LETTERS SENT IN 2018. 3,227 LETTERS SENT TO REAUTHORIZE THE AUTISM CARES ACT 200+ ADVOCATES HELD MEETINGS WITH STATE LEGISLATORS AT OUR ANNUAL DAY ON THE HILL EVENT.
