Delta Housing Corporation of the District of Columbia (DHCDC) was organized under the District of Columbia Non-Profit Corporation Act to provide decent, safe and sanitary housing for low and moderate-income persons, particularly for the elderly and the handicapped. DHCDC developed and operates Delta Towers Apartments, a 150-Unit elderly and handicapped apartment project located in Washington, DC, under the provisions of Section 202 of the National Housing Act, in conjunction with a capital advance agreement provided by the U.S. Department of Housing and Urban Development(HUD).

Once the Board approves the draft Form 990, the President will sign the Form 8879-EO which accompanies the Form 990 for submission to the IRS.
