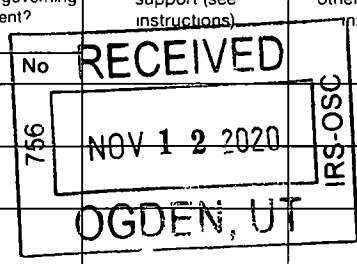

Part VI, Line 5: During the course of 2019 and following the resignation of the executive director the board of directors of Horizons Expeditions Inc. became aware of a substantial operations deficit. A financial analysis of 2018 and some earlier financial records raised a number of questions about financial management and reporting. This analysis discovered no errors in reporting to Federal and State authorities, however it raised questions about the use of funds that the board had designated be held for specific purposes. Among the recorded expenditures for prior years were several transactions which are currently the subject of an investigation by Richmond City Police and the Office of the Richmond City Commonwealth's Attorney, case # 201905230421. Until that investigation is complete we cannot state categorically the causes for the operational deficit. In the meantime the board and staff of Horizons Expeditions Inc are working to rectify the carried-forward deficit.
