CETACEANS CAMPAIGN: EIA IS UNDERTAKING EXTENSIVE RESEARCH INTO THE NUMEROUS THREATS TO GREAT WHALES AS WELL AS SMALL WHALES, SUCH AS BELUGAS AND NARWHALS. OUR CAMPAIGN WORK HAS DETAILED THE IMPACTS OF SMALL CETACEANS WORLDWIDE. THESE SMALLER SPECIES ARE NOT PROTECTED BY THE INTERNATIONAL BAN ON COMMERCIAL WHALING AND ARE HUNTED FOR FOOD, FOR USE AS SHARK BAIT OR KILLED IN NETS OF FISHING OPERATIONS. EIA RESEARCH HAS ALSO DOCUMENTED OVERHUNTING OF UNPROTECTED SPECIES OF DOLPHINS AND PORPOISE.
