Seaweed is a valuable international ocean macro-algae resource.  
Seaweeds absorb up to five times the amount of carbon as land-based plants.  
There are over 10,000 species of seaweeds worldwide.  
Divided into three classifications: Phaeophyta (brown seaweeds); Rhodophyta (red seaweeds); Chlorophyta (green seaweeds).  
None of the seaweed macro-algae are toxic, and all are a rich source of healthy dietary minerals and salts, including Calcium; Iodine; Iron; and Potassium.  
Seaweed is also highly sustainable in comparison to other crops and enables carbon sequestration.  
Ocean Science R&D project covers: Mapping Intertidal Macro-Algae Resources; Experimental Seaweed Cultivation R&D; Sustainable Harvesting; Innovative Seaweed Production R&D; Innovative Seaweed Food Development
