THAT NO BOARD MEMBER CAN BE INVOLVED IN DISCUSSIONS ASSOCIATED WITH HIS/HER RE-ELECTION. CLARIFYING THAT OFFICERS OF THE BOARD ARE ELECTED BY BOARD MEMBERS AND THAT ANY VACANCY SHALL BE FILLED BY A MAJORITY VOTE OF THE REMAINING BOARD MEMBERS AT THE TIME OF VACANCY, SUBJECT TO THE QUORUM PROVISIONS OF THE BY-LAWS.
