THE \$25,000 FELLOWSHIP IS AN OPPORTUNITY FOR MID-CAREER OR SENIOR-LEVEL PROFESSIONALS TO DEDICATE THE EQUIVALENT OF 3 MONTHS' TIME OVER THE COURSE OF ONE YEAR TO NURTURE EMERGING IDEAS AND TO THINK DEEPLY.
