B. ONE CHAPTER PRESIDENT SHALL BE ELECTED BY THE CHAPTER PRESIDENTS TO SERVE AS A DIRECTOR. THIS ELECTION SHALL TAKE PLACE BY MAIL BALLOT AT THE SAME TIME AS THE VOTE FOR DIRECTORS. ONE ALTERNATE SHALL BE ELECTED WHO MAY ATTEND BOARD MEETINGS AND VOTE 118 IN THE ABSENCE OF THE ELECTED CHAPTER PRESIDENT-DIRECTOR.
