CADCA UTILIZED ITS PREVENTION NETWORK TO HELP INCREASE AWARENESS AND USE OF JOHNSON & JOHNSON'S OVER THE COUNTER (OTC) MEDICINE SAFETY PROGRAM, GEARED SPECIFICALLY TO 5TH AND 6TH GRADERS.
