Webinars are held monthly to educate producers about fixed annuities. NAFA works with CapCity Advocates to assist in educating and informing federal regulators, legislators and policymakers about fixed annuities and their role in financial planning, increase awareness of NAFA and its mission to promote fixed annuities, and work with agencies and trade associations in activities that further our mission and the number of Americans who own a fixed annuity.
