MSI SUPPORT - EXPANDING DELIVERY OF GLOBAL FAMILY PLANNING SERVICES IN LATIN AMERICA. MSI's programs in Bolivia continued to expand access to contraception and serves as one of the few providers of long-acting reversible and permanent methods. This was largely through the success of mobile outreach programs, which deliver services in some of the most remote communities in the country. In Mexico, MSI continues to increase access by strengthening its clinic network, expanding its call center services, and providing training and capacity-building to reproductive health providers. A program in Mexico to test tel-medicine's feasibility in reaching more clients in need has shown positive and encouraging results.
