Orphan Care:Our Orphan Care segment includes Child Protection Centers (CPCs), Transition and Missions programs. Within our Child Protection Centers (which we support, but do not own), we serve around 290 rescued children through five CPCs, or homes, across Nicaragua. We call them homes because the children are raised in a family environment with caregivers and staff that love the children as if they were their own. ORPHANetwork supports ministries whom rescue children that have been abandoned, abused, socially orphaned or truly orphaned. We focus on Seven Targets to create new opportunities for life for these children: following Christ, life skills and education, computer and English skills to get a good starter job, giving back to others at the CPC and serving in a local church. This program also includes leadership development initiatives.

Preparing for Jobs:Our Job Preparedness segment includes Job Training and the After-School Education Program (ASEP). The Job Training program empowers young adults from our partner LCIs to learn a trade and gain employment.
