Mentees' multi-genre, multimedia work is published in outlets including Teen Vogue, BuzzFeed, and The New York Times, performed at Lincoln Center and the United Nations, and wins hundreds of Scholastic Art & Writing Awards. 100% of Girls Write Now seniors are accepted to college armed with confidence, portfolios, and life-long bonds.
