The West Virginia Roundtable is one of the sponsors of the West Virginia Business Summit which is coordinated by the West Virginia Chamber of Commerce and was attended by approximately 1,000 people in 2019. A variety of speakers and panels focused on stimulating business activity in West Virginia. The Roundtable held its annual meeting in conjunction with the Summit and heard presentations by the Deans of three schools of business in West Virginia and from Senator Shelley Moore Capito.

The West Virginia Roundtable held two other membership meetings during the year. The January meeting included presentations and Q&A sessions with the President of the West Virginia Senate and the Speaker of the House on the topic of economic development initiatives by the legislature. The April meeting included presentations by Mr. Brad Smith, Executive Chairman of Intuit, and by representatives from the Shale Crescent organization about economic development in the Ohio River industrial area.

The West Virginia Roundtable significantly increased its communications with members during the year. This included in-person visits, website updates, and the production of newsletters.
