THE CENTER'S PURPOSE IS TO PROMOTE AWARENESS OF THE VALUE OF MEDITATION, CONTEMPLATION AND SILENCE AS A WAY TO UNCOVER THE TRUTHS WITHIN THE HEART. DURING THE YEAR, THE CENTER CONDUCTED 27 MEDITATION RETREATS VARYING IN LENGTH FROM 2 TO 13 NIGHTS, FOR A TOTAL OF 140 RETREAT NIGHTS. THE RETREATS WERE CONDUCTED BY 27 TEACHERS AND ATTENDED BY 698 PARTICIPANTS. TEACHERS PRIMARILY REPRESENT A VARIETY OF BUDDHIST TRADITIONS. ATTENDEES TAKING ADVANTAGE OF SCHOLARSHIP OFFERINGS TOTALED 130, OR APPROXIMATE 18% OF ATTENDEES.
