CURRENT MEMBERS INCLUDE ACTIVE AND RETIRED EDUCATORS, WRITERS, INVESTORS, SCIENTISTS AND ENGINEERS. THE FOUNDATION CONTINUES TO MAINTAIN A NUMBER OF PROGRAMS WHICH EXTEND ITS EDUCATIONAL PURPOSE TO A LARGE SEGMENT OF THE GENERAL PUBLIC. IT RELIES ON A BOARD OF ADVISORS OF TWELVE DISTINGUISHED PROFESSORS FROM FIVE COUNTRIES TO GUIDE ITS EDUCATIONAL PROGRAM AND, IN PARTICULAR, AS AWARDS PROGRAM THAT GRANTS FELLOWSHIPS FOR DOCTORAL STUDIES AND AWARDS PRIZES FOR POETRY TRANSLATION AND SCHOLARLY ESSAYS. FIVE WEBSITES PROVIDE A VIRTUAL LIBRARY OF SEVERAL HUNDRED PAGES OF MATERIAL TO SUPPORT THE STUDY OF POETRY, MUSIC AND DRAWING. GRANTS HAVE BEEN MADE TO MANY PERFORMING ARTISTS INCLUDING MUSICIANS, DANCERS, FILMMAKERS AND THEATRE GROUPS. VOLUNTEERS HAVE WORKED WITH CLASSROOM TEACHERS AT THE UNIVERSITY AND SECONDARY LEVELS IN SPAIN, ITALY, CHILE AND THE US TO DEVELOP CURRICULA IN SPANISH LANGUAGE POETRY.
