



Part 3. Organization's Primary Exempt Purpose: The Belt Volunteer Ambulance is a public charity formed to provide no-cost or low-cost pre-hospital emergency care and emergency ambulance transportation for residents of Belt and residents of Eastern Cascade County, Montana.

Part 3: Achievements: During 2019, Belt Ambulance (BVAS) provided medical care to over 150 residents of our area and surrounding areas.

All services were provided by volunteers. BVAS provided advanced training sessions where members of surrounding services were invited to attend at no charge to either individuals or their services. BVAS personnel attended symposiums throughout the State to further their knowledge and abilities in patient care. BVAS acquired training in administering Narcan to OD patients and the drug is now on both ambulances. An EMT class is scheduled to start in early 2020 with attendance of 10 anticipated.
