THE INTERESTED PERSON MUST NOT BE PRESENT IN MEETINGS WHERE THE BOARD DISCUSSES THE CONFLICT TRANSACTION AND POSSIBLE MORE ADVANTAGEOUS TRANSACTIONS OR ARRANGEMENTS. ANY COVERED PERSON WHO FAILS TO DISCLOSE ACTUAL OR POSSIBLE CONFLICTS OF INTEREST IS GIVEN AN OPPORTUNITY TO EXPLAIN THE ALLEGED FAILURE TO DISCLOSE AND WILL BE SUBJECT TO APPROPRIATE DISCIPLINARY AND CORRECTIVE ACTION.
